The Panel

The Panel is made up of six individual and six organisational members that meet up to four times a year. As well as aligning with delivery of the outcomes in the City of Adelaide Disability Action and Inclusion Plan 2019 - 2022, during a Panel's term there is a major focus on case studies across council.

They provide timely and expert advice to council teams on real life deliverables. This advice creates better project outcomes and helps to make our great city safe, accessible and inclusive for all city users.

A Panel's term is usually for two vears however for the Panel that commenced in 2019, their term was extended to the first quarter of 2022 due to the impacts of COVID-19.

Despite the many challenges in their term that come with a global pandemic, the members demonstrated great leadership and commitment to their roles and to the importance of not wavering on access and inclusion outcomes.

The Panel improved access and inclusion outcomes across the following areas:

Park Lands, Open Space and Recreation

- Master Plan design and inclusive playspaces
- informing asset management and planning

Social and Economic Planning

- navigating COVID-19 impacts and innovations
- implementing the Disability Access and Inclusion Plan

Community Facilities, Art, Culture and Events

- making public events more accessible
- design and demand for accessible toilets and change facilities

Streets and Transportation

- advice about asset management including accessible parking
- improvements to pedestrian safety and public transport usage

Environmental Sustainability

advice on climate planning and engagement

Community Safety

- addressing disability discrimination
- identifying problematic locations in the city

Communications & Representation

- making council elections more inclusive
- improving accessible council communications

Case Study 1

Inclusive playspaces

A project that took three years from inception to delivery, Panel members were involved right from the beginning in the design of the Quentin Kenihan Inclusive Playspace, including two individual members joining a further internal council advisory group.

The playspace was launched in December 2020 and highlights include:

- wheelchair accessible swing and trampoline;
- 'Super Loop' challenge track;
- 'sQiggle' public art in honour of Quentin;
- · Changing Places facility; and
- Sound and sensory garden.

Council has now adopted the Touched by Olivia and Department of Human Services inclusive playspace guidelines.

The project was supported by the Government of South Australia.



Case Study 2

Opportunity at the City of Adelaide

A partnership with Disability Employment Service (DES) providers and the City of Adelaide, the Job Access Employment Project has helped to improve access to opportunities and inclusive practices at the council.

Key features of the project included:

- improving equitable access to role vacancies;
- resources for leaders;
- Inclusion Statement for organisational and public communications and recruitment processes;
- Job Access Disability Awareness Train the Trainer program completed by the People team; and
- collecting relevant data in recruitment processes and staff Culture Survey to measure our inclusion progress.

As well as the council working directly with DES providers, the Panel were involved at each step, providing critical advice, reflection and the insights of their lived experience.



Case Study 3

Events for Everyone

Funded by a Local Government Association (LGA) grant, the **Accessible Events Project** was led by Alexandrina Council, in partnership with the
City of Adelaide, the City of Mount Gambier, Purple Orange consultants and people living with disability.

Aligned with a co-design approach, the Panel provided valuable insights to the consultants from their lived experience of organising and attending events at each step of the project. Emphasised was the need for accessible information prior to ticket purchase, accessible venues, and staff at the event with knowledge of accessibility.

After auditing several public events in all three council areas, key outcomes from the project include:

- training of staff and external event organisers;
- accessible events guidelines and checklists;
- development of an Accessible Events Audit Tool to be available for LGA members; and
- learnings reflected in the newly updated City of Adelaide Event Guidelines.
