EXECUTIVE SUMMARY

The purpose of this report is to seek the approval of Council to provide the Minister for Human Services a licence to create a temporary support and isolation hub in the Park Lands for visitors from remote Aboriginal communities who are rough sleeping and have tested positive to COVID-19. The Hub will provide a safe and culturally supportive space for people who need to isolate but have no other appropriate place to do so.

Consideration in confidence is sought because the report contains information which, if discussed in public, could reasonably be expected to prejudice appropriate, sensitive consideration of the matter prior to the determination by Council and the State Government and negatively impact the opportunity for Council to participate in future like considerations and discussions.

RECOMMENDATION

That Council

- 1. Notes that the application from the Minister for Human Services (the Minister) for a licence to operate a camp in Wirrarninthi Park 23 West to assist with health monitoring, isolation and quarantine arrangements for Aboriginal Communities is inconsistent with the approved Community Land Management Plan (CLMP) for that section of the Park Lands.

GROUNDS AND BASIS FOR CONSIDERATION IN CONFIDENCE

Grounds

Section 90(3) (j) of the Local Government Act 1999 (SA)

- (j) information the disclosure of which—
 - (i) would divulge information provided on a confidential basis by or to a Minister of the Crown, or another public authority or official (not being an employee of the council, or a person engaged by the council); and

(ii) would, on balance, be contrary to the public interest

Basis

This Item contains material provided on a confidential basis which the State Government has requested be considered in confidence on the grounds that the details of the request are sensitive and nature and the release of this information prematurely may be misleading. The disclosure of information in this report could reasonably be expected to prejudice the position and any negotiations with external parties of the State Government.

Public Interest

The City of Adelaide is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances because the disclosure of information may result in release of information prior to the finalisation of the matter by the State Government. The disclosure of this information may materially and adversely affect the viability of the matter and prejudice Council's ability to discuss/participate or influence a proposal for the benefit of the Council and the community in this matter which on balance would be contrary to the public interest.

DISCUSSION

1. Since the closure of Puti on Kaurna Yerta (PKY), the Remote Aboriginal Visitor Outreach and Service Hub in the South Park Lands in December 2021, we have been working closely with partners to continue to coordinate responses to remote visitors who are sleeping rough in the city and Park Lands.

- 2. The Department of Human Services has continued the support work from PKY by establishing a Remote Visitor Outreach Team (the Team), who have been working across the city and in metropolitan tenancies to continue to support and achieve outcomes for vulnerable people.
- As COVID-19 cases have become more prevalent in South Australia, the Team have identified a high risk of COVID-19 infections spreading amongst this cohort who often live and socialise in large groups, use limited personal protective equipment and are living with underlying health problems.
- 4. Due to the overcrowding of tenancies, or people sleeping rough, it is difficult for anyone diagnosed with COVID-19 to safely and appropriately isolate from family and community members and the broader community. To address this risk, the State Government is establishing isolation facilities that will provide culturally supportive places for people to isolate and remain safe.
- 5. The Minister for Human Services has written to the Lord Mayor requesting Council's approval for a licence agreement to occupy an area of the Park Lands for a support and isolation hub view Link 1.
- 6. The site will operate along similar principles of the successful Puti on Kaurna Yerta model, however, will be specifically for those who have tested positive and close contacts with a requirement that they remain at the site for their isolation period.
- 7. A specific location is yet to be identified, although DHS have indicated that an area in Wirrarninthi (Park 23) would be appropriate.
- 8. If supported, the Chief Executive Officer will negotiate an appropriate space in the Park Lands that:
 - 8.1. Is easily accessible for services, SAPOL and maintenance requirements
 - 8.2. Has the required space for communal gathering, activities and separated spaces for families and groups
 - 8.3. Minimises disruption to other Park Lands activities or the broader community.
- 9. The site will include alcohol consumption while being supervised by on-site support workers. This is recognising that there is a proportion of this cohort who need to isolate while living with alcohol dependency and will need support to manage this.
- 10. As a committed partner of the Safety and Wellbeing Taskforce, it is recommended that City of Adelaide support the agreed response of Government agencies, non-government services and Aboriginal leaders.
- 11. If supported, the Chief Executive Officer will execute a licence agreement with the Minister for Human Services that contains terms similar to the previous licence agreement for Puti on Kaurna Yerta.
- 12. A specific location and length of time is yet to be identified, however given the urgency to establish the response for public health and safety, it is requested that Council authorise the CEO to negotiate the details with the Department of Human Services. Council Members will be provided with an update when the outcomes have been decided.
