Industry played a major part in the historical development of the city, brewing being just one of the activities undertaken in industrial Adelaide. The Calvert engraving dated 1876 shows over thirty industrial stacks and the only chimney which appears to have survived is the stack at the Lion complex in North Adelaide. This complex was imaginatively adapted for use as an entertainment complex in the early 1970s.

The demolition of industrial buildings in the city has been widespread and there are few reminders of this aspect of nineteenth century Adelaide. Of the first main breweries which came into existence in 1843-44 in South Australia only Johnston's at Oakbank and the former Wyatt Street brewery retain buildings more or less intact. The Lion Brewery although later, was almost as significant a concern.

The Lion Brewery and Malthouse was erected for Bailey and Stanley. Daniel Garlick, architect,

advertised for tenders in 1871 for the excavation of a large cellar and the erection of a brewery.

In 1872 tenders for the construction of the malthouse, kiln and store were advertised. The design is similar to that erected in Clare (now the Enterprise Winery), also designed by Garlick. Glen Osmond bluestone was used in the construction undertaken by Brown and Thompson. By 1872 the brewery was described as having a cellar, 5 feet by 25 feet, with a malt store of similar dimensions above. Later additions consisted of extensions to the malt kiln.

In 1873 Bailey sold his interest in the brewery to W.H. Beaglehole, the resulting company having as its operating partners Beaglehole, Johnston, James and Gasquoine. Further alterations to the brewery were carried out in 1873 and 1875 to designs by James Cumming, and in 1880 Cumming called tenders for the construction of the hotel at the corner of Jerningham and Melbourne streets. By 1883 the present form of the complex was largely achieved.

Beaglehole and Johnston continued operations until 1888 when the Lion Brewing and Malting Co. Limited was formed. From 1914 the Walkerville Co-operative Brewing Co. Limited supplied the Lion Hotel with beer, and the brewing section of the complex Lion ceased production, although the production of aerated waters and cordials continued for some time.




