TERRACE HOUSES (Formerly Darcy Lever Terrace)

33-39 Hurtle Square

Hurtle Square is enhanced in appearance by the survival of high quality residential terraces such as Darcy Lever Terrace with its substantial veranda. The *South Australian Register*, 23 March 1878 recorded that 'In Hurtle Square, Mr Harvey has just completed four unusually large two storied [sic] dwelling houses which are named Darcy Lever Terrace. They are provided with deep ornamental verandahs and balconies.'

Simon Harvey was a builder, prominently connected with the industry, in Adelaide and the neighbouring suburbs, especially Unley Park.

His houses were designed for wealthy families, and Harvey Street, Unley Park, was named after him, although at the time of Queen Victoria's Jubilee he consented to the name being changed to Victoria Avenue. Harvey was born at St Austell, Cornwall, and came to South Australia in 1861. He first worked in a timber yard in Flinders Street. He then started his own business opening a mill at Port Adelaide and acquiring an interest in the Lion Timber Mills and directing the Globe Timber Mills. He retired in 1923 and died in 1927 at the age of eighty four.

The terrace remained in Harvey's ownership until 1886 when it was sold to Roland Strachan. It remained in single ownership until the late 1960s when refurbishment took place, the individual dwellings being sold in late 1971 and early 1972.


